Objectives & Goals

The objectives of AmCham Macau are to:

Organization

The governing body of AmCham Macau is the Board of Governors which consists of 15 members elected for two-year terms. From the Board of Governors 6 officers are elected for two-year terms.

The Supervisory Committee is composed of 3 Chamber members and is appointed by the Board of Governors.
